PERMIT TO CARRY ONLINE APPLICATION

- REVIEW all the information that you have entered is correct before submission specifically, name, telephone numbers, email addresses, and ORI [NJ0021900] FORT LEE POLICE DEPARTMENT.
- Your NJ Driver's License and Firearms ID card MUST MATCH your current FORT LEE address.
- Permit is valid for TWO [2] years.
- Please note that there are **NO refunds** for WITHDRAWN applications.
- If an error was made in the submitted application, **DO NOT** submit a NEW application. CONTACT the FLPD Records Bureau

FINGERPRINTING:

- If you have never been fingerprinted for firearms purposes in New Jersey, your first step is to apply for a Firearms Identification card refer to Firearm Identification Card online application instructions.

PERMIT TO CARRY application submission instructions as follows:

- 1. Website https://www.njportal.com/NJSP/ConcealedCarry/
- 2. ORI NJ0021900 FORT LEE POLICE DEPARTMENT
- 3. Upload a recent COLOR Passport style photograph [2"x2"] light background including head & shoulders.
- 4. Upload a completed SP182 "Safe Handling & Proficiency Certificate" signed by a certified firearm instructor.
- 5. Enter the handgun information for ALL handguns that you intend to CARRY with this permit [Serial number / Caliber / Make / Model]
- 6. Upload a completed SP066 Consent for Mental Health Records if you lived outside of New Jersey in the last TEN [10] years.
- 7. **REVIEW** and **PRINT** a copy of all documents for your records prior to submission. Applications cannot be modified.
- 8. Character References will be emailed automatically with a questionnaire to complete.
- 9. Once you have completed your online application, **ADD** to your email Contact list sfong@FortLeePolice.org further instructions will be emailed.

Applications will not begin to be processed until all documents are received by FLPD:

- 1. Statutory fee \$150.00 cashier's check / money order only [payable to FORT LEE POLICE DEPARTMENT]
- 2. Proof of residency [FORT LEE] valid NJ Driver's License [current address]
- 3. Firearms ID card issued from FORT LEE POLICE DEPARTMENT
- 4. US Citizens to provide Birth Certificate or US Passport
- 5. Naturalized Citizens to provide US Naturalization Certificate
- 6. NON-US Citizens to provide Alien Registration ID card AND Social Security card

*The falsification of information on any of the applications for Firearms Permits is a violation of N.J.S. 2C:39-10C and is a crime of the third degree. Any falsification may result in criminal charged against you.
